PARENT’S PLEDGE OF COOPERATION ~ 2015-2016

1. I have read (or will read) the entire EVCS Parent-Student Handbook and do agree with the Statement of Faith and all guidelines and rules as set forth. (Online at www.evcs.org)
2. Because of limited enrollment and the stringent economy, I will keep all financial obligations up to date. In the event of withdrawal, transfer, or expulsion, I will be responsible for full payment of tuition and other fees. Full payment of tuition must be made through the end of the calendar month. The school reserves the right to withhold report cards and student records until tuition and other fees have been paid in full. By signing the “Parent’s Pledge of Cooperation,” I am authorizing the school to withhold report cards and other records until tuition and other fees have been paid in full.
3. In full cooperation with the school, I will attend the PTF meetings and other school meetings. I sincerely pledge my loyalty to the aims and ideals of the school and will bring any and all questions and criticisms directly to the teacher or administration so that they may properly be considered by those in authority.
4. Should my child(ren) become involved in athletics/cheerleading, I will then volunteer my time for gate and concession stand work at home ball games.
5. The teacher and administration are hereby given full discretion in the discipline of my child(ren). This would include the issuing of detention, suspension and expulsion from school if necessary. Corporal punishment will only be used as a last resort, and at the parent’s request and only with a signed consent form.
6. The teacher has full discretion, along with the administration, for the grade placement of my child(ren).
7. By enrolling my child(ren), it is my desire to have him/her attend the entire school year.
8. EVCS is considered God’s property. Respect for the appearance and care of our school property is a part of our Christian testimony. I realize property destroyed or damaged by my child will be repaired or replaced at my expense.
9. Every account will receive a yearbook. Additional copies may be ordered at a cost of \$40 each. Yearbooks for the previous school year are delivered in the fall (usually August or September). The free yearbook needs to be picked up by mid-December. Yearbooks will be distributed to accounts that are current. If an account has an outstanding balance, the yearbook will be distributed when the account is settled. If it is after mid-December, then the yearbook may not be available to distribute. We do not mail yearbooks.
10. I understand the importance of fund-raisers to EVCS and agree that I and my child(ren) will take an active role in all fund-raisers, including the Walk-A-Thon, while they are a student at EVCS. Should I choose not to actively participate and follow the guidelines with the major fund-raisers, I will be assessed a fee.
11. I recognize that our participation is needed in prayer, service, and gifts in order to properly share in the training of my child(ren).
12. The school administration will be the final authority on all matters.
